## **Tips**

- Don't need to figure it out yourself
- Don't launch a non-compliant website/email
- Security benefits are associated with the domain name; a website is a website
- Consider timing migration to a brand-impacting event
- Determine if new website and email will be coordinated or phased

## Tips (cont'd.)

- For email, take inventory of those who send on your behalf
- Budget for resources; plan now for 2018
- Assemble the right team
- Engage relevant service providers
  - Most large core processors have known about
     .BANK for years; don't take no from them


## .BANK / .INSURANCE Basic Managed DNS

- Keep it simple develop your .BANK strategy
- Forward your .BANK name to your main website
- Test your email and other web services
- Begin light usage of your domain name
  - 50,000 DNS queries per month
  - Feature rich and transactional security
  - Fulfill .BANK requirements

TLS must be implemented using protocol versions	If using DNS Manager, Verisign's web portal or API, all communications are protected by TLS
